On February 10 2022, at 10:00 AM at the monthly branch meeting we are excited to have Matthew Junker, Public Relations Specialist for the Municipal Authority of Westmoreland County address the topic "The Safety of Our Water and EPA's Lead and Copper Rule". He will be reviewing new regulations which go into effect in 2024 dealing with how the lead content in drinking water is handled by water authorities. As he serves on a steering committee of the Public Affairs Council at the American Water Works Association charged with addressing the new regulations, he is in a unique position to provide insight into how these will effect our local water system. He will explain how the regulations will change how utilities are required to present information to their consumers. Since the Biden administration announced additional changes to the new regulations in December, Mr. Junker will have the latest information on implementation. He will also discuss how local water is tested, the results of local testing and how lead contamination issues such of those effecting Flint Michigan and the city of Pittsburgh are avoided here.

A now dilapidated Queen Anne style home in Homewood was the former headquarters of the National Negro Opera Company, the first permanent African-American Opera company in the nation. In 2020 the building was declared one of America's Most Endangered Historic Places. The house has recently received several grants and is undergoing restoration.

Jonnet Solomon, building owner and Executive Director of the National Opera House, will describe, via Zoom, her goals for the house and her vision for what she hopes it will become.

The books for the 2022 Great Decisions discussion group have arrived. There are five (5) left at a cost of \$32 each. The topics for 2022 are:


